Founded in 1985, Jabadao works across the UK and beyond developing understanding of how children learn in their bodies, and how they build a confident physicality.

Enhancing wellbeing lies at the core of the practice.

We are a small team and work collaboratively. We have a base in Suffolk, but each practitioner works from home wherever they live - and travels to teach across the UK. We hook up as a team on Zoom (frequently) and face to face for training and other development activities.

### **Jabadao Practitioner Job Details**

### The nature of the role

- You will become a Jabadao team member
- The work is on a freelance basis
- Jabadao will book days with you as far in advance as possible
- You will lead work organised by Jabadao. This is not a franchise model.

### In the short term:

- you will be involved in training and development to learn the approach. This will be a mixture of team training and shadowing
- you will build your understanding of the theoretical base, using company training materials and reading around the theory
- you will lead training on an ad-hoc basis potentially 1 or 2 days a month. We aim for this to grow and develop over 2025
- The fee will be £300 per delivery day and £100 per day for training/shadowing days
- We cover all travel and accommodation expenses and provide a budget for refreshments
  - you will organise your travel arrangements and submit expenses claims
  - hotels will be booked and paid for by the company in advance
- You will be covered on Jabadao public liability insurance for all delivery days
- We will conduct a DBS check and ask you to complete safeguarding and paediatric first aid training

### The training you will lead

- will be at:
  - conferences
  - training events organised by early years advisors across a geographical area
  - with teams in special schools, primary schools and nurseries
- all admin will be done by the Jabadao team

Appointments will be subject to completion of an Enhanced DBS check and checks to ascertain whether you are entitled to work in the UK

### **Role requirements**



#### ESSENTIAL

- You are excited to develop the Jabadao approach alongside the team
- You are happy to work on an occasional basis, booking teaching commitments in advance
- You are able to travel away from home and stay away for one to three nights

#### Supporting spontaneous movement play

- You can move spontaneously with both children and adults without the need for pre planning or specific games
- You can match the energy, ideas and physicality of babies and children
- You understand that safety is paramount when supporting babies and children to be fully physical

#### Your ability to lead training and learning experiences with adults

- You have experience of supporting children's and adult's learning
- You are warm, approachable and enjoy taking people on a journey to change practice
- You can listen and relate to participants' stories, realities and challenges
- You can adapt, stay positive and be creative when things change on the hoof
- You can clearly articulate information and develop enthusiasm in others

#### Freelance work across the country

- You are able to travel anywhere in the UK to lead training, staying away when necessary
- You are able to attend three-day residential team training workshops on an occasional basis
- You are happy working independently

# **Job Application Privacy Notice**

### What information do we collect?

Jabadao collects a range of information about job applicants.

### This includes:

- your name, address and contact details, including email address and telephone number
- details of your qualifications, skills, experience and employment history
- and for the purposes of making reasonable adjustment (we are committed to making life and work fit together well):
  - your carer responsibilities
  - whether or not you have a disability

### Information about your entitlement to work in the UK

Jabadao may collect this information in a variety of ways. For example, data might be contained in:

- application forms, CVs or resumes, obtained from your passport or other identity documents
- collected through interviews or other forms of assessment
- we may also collect personal data about you from third parties, such as references supplied by former employers. We will seek information from third parties only once a job offer to you has been made and will inform you that we are doing so

Data will be stored in a range of different places, including on your application record, in HR management systems and on other IT systems (including email).

#### Why do we process personal data?

Jabadao has a legitimate interest in processing personal data during the recruitment process and for keeping records of the process in order to manage the recruitment process, assess and confirm a candidate's suitability for employment and decide to whom to offer a job.

We process such information to meet our obligations and exercise specific rights in relation to employment.:

- we need to process data prior to entering into a contract with you and if we enter into a contract with you
- in some cases, we need to process data to ensure that we are complying with our legal obligations. For example, it is mandatory to check a successful applicant's eligibility to work in the UK before employment starts
- we may also need to process data from job applicants to respond to and defend any legal claims
- Jabadao may process special categories of data, such as information about ethnic origin, sexual orientation or religion or belief, to monitor recruitment statistics
- we may also collect information about whether or not applicants are disabled to make reasonable adjustments for candidates who have a disability

### Who has access to data?

Your information may be shared internally for the purposes of the recruitment exercise. We will not share your data with third parties, unless your application for employment is successful and we make you an offer of employment. We will then share your data with former employers to obtain references for you, employment background check providers to obtain necessary background checks.

### How does Jabadao protect data?

We take the security of your data seriously. We have internal policies and controls in place to ensure that your data is not lost, accidentally destroyed, misused or disclosed

### For how long does Jabadao keep data?

If your application is unsuccessful, the organisation will hold your data on file for six months after the end of the relevant recruitment process.

If your application is successful, personal data gathered during the recruitment process will be transferred to your Human Resources file (electronic) and retained during your employment. The periods for which your data will be held will be provided to you in a new employee privacy notice.

### Your rights

As a data subject, you have a number of rights. You can:

- access and obtain a copy of your data on request
- require the organisation to change incorrect or incomplete data
- require the organisation to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing
- object to the processing of your data where Jabadao is relying on its legitimate interests as the legal ground for processing.

### What if you do not provide personal data?

You are under no statutory or contractual obligation to provide data during the recruitment process. However, if you do not provide the information, we may not be able to process your application.
